## **Executive Summary**

The political crisis in Abkhazia highlights the region's deep-seated struggles with governance, economic sovereignty, and reliance on Russian support. Public unrest erupted over a proposed Russian investment agreement, seen as a threat to the region's autonomy. The protests escalated into violence, culminating in President Aslan Bzhania's resignation. The crisis underscores Abkhazia's fragile political landscape and its precarious position within the broader geopolitical framework of the Caucasus.





## Background

Abkhazia, a self-declared independent region, is recognized internationally as part of Georgia but remains under Russian influence following the 2008 Russia-Georgia war. Its economic and political reliance on Moscow shapes much of its internal and external dynamics.

The latest crisis was sparked by a controversial investment deal with Russia that allowed for real estate investments, stoking fears of eroded sovereignty and economic exploitation. The opposition mobilized widespread protests, accusing the government of compromising the region's autonomy and long-term economic stability.





## **Key Developments**

### **Trigger of Protests**

- Opposition leaders rallied public dissent against the Russian investment deal, labeling it a threat to Abkhazia's sovereignty.
- The parliamentary debate on the agreement became a flashpoint, leading to mass demonstrations.

#### **Violence and Escalation**

• Protests turned violent as demonstrators stormed government buildings in Sukhum, clashing with security forces. At least 14 injuries were reported.

### Resignation of President Bzhania

- Under intense pressure, President Aslan Bzhania resigned after negotiating with the protesters.
- Vice President Badra Gunba assumed interim leadership, with plans for early elections.





## **Key Developments**

#### **Political Stalemate**

- Opposition leaders rejected partial compromises, including a conditional resignation offer by Bzhania, demanding immediate withdrawal of the investment deal.
- The crisis left governance in disarray, with a temporary government proposed by opposition groups.

#### **Economic Disputes**

- Critics of the agreement raised concerns over inflated housing prices, marginalized local businesses, and deepened economic dependency on Russia.
- Russia defended the deal as equitable and beneficial for dual citizens.

#### **Historical Context**

 Abkhazia's unresolved post-Soviet ethnic and territorial disputes continue to drive its political and economic challenges.

## Analysis

Domestic Dynamics: The opposition capitalized on widespread fears of economic exploitation, using the protests as a platform to challenge President Bzhania's administration. The crisis highlights systemic governance flaws and cyclical political instability in Abkhazia.

Regional Implications: Georgia may view the unrest as an opportunity to reassert claims over Abkhazia. Russia's measured response suggests a cautious approach, balancing influence while avoiding overt intervention.

Economic Challenges: The investment agreement illustrates the tension between modernization aspirations and sovereignty preservation. Continued reliance on Russian economic support limits Abkhazia's ability to diversify its economy and reduces political autonomy.





## Recommendations

#### 1. Facilitate Mediated Dialogue

 Neutral parties should mediate between government and opposition leaders to de-escalate tensions and establish a roadmap for reforms.

#### 2. Revise the Investment Agreement

 Amendments should address sovereignty concerns while fostering sustainable economic cooperation with Russia.

#### 3. Strengthen Institutional Governance

 Governance reforms are crucial to building political resilience and ensuring accountability in crisis management.

### 4. Investigate External Influence

 Claims of foreign interference in the protests should be transparently investigated to maintain public trust and regional stability.





## **Conclusion**

The Abkhazia crisis reveals the region's persistent vulnerability at the crossroads of domestic governance challenges and external geopolitical pressures. Resolving the crisis will require a balanced approach that addresses both internal demands for sovereignty and the realities of economic dependency on Russia. Stabilizing Abkhazia is critical not only for its future but also for mitigating regional tensions in the Caucasus.

## Notable Updates
